This week's newsletter brings you an update on upcoming NAAS platform maintenance, Knowledge Hub and assessment centre availability.

### **Platform maintenance**

The team will be conducting maintenance work on the NAAS platform from 10pm on **Thursday 5 March** to 9am on **Monday 9 March**. This means you will not be able to access the platform at all during this time. We apologise for any inconvenience this may cause. Please ensure this message is passed on to your NAAS users.

# NAAS regional meetings

Thank you to everyone who has attended a regional meeting over the past few weeks. It's fantastic that so many of you were able to come together to share your progress and experiences.



We've taken away some valuable insight that will help us to improve the programme. For now, we want to share a few updates with you in response to your queries and feedback.

• Scalar results: Thank you for your feedback on the scalar section of our results

page, which we are working to improve. For now, this <u>results boundaries slide</u> sets out further explanations and an example to aid in understanding the scalars.

- Platform updates: We are currently working hard to make changes to the NAAS
  platform. These changes will give you access to:
  - a bespoke dashboard that will allow you to add candidates directly onto the platform
  - your candidates bookings and cancellations
  - aggregated results data (where candidates have consented to share their results).

We will be sharing these changes with you all at the next Learning Day, we are also planning to run user testing sessions. If you would like to be involved in these session please contact: Jan.Nayeem@education.gov.uk.

• Consent to share results: We understand that there are still concerns around being able to support your social workers who have chosen not to consent to share their results.

While a number of sites have said that some candidates do not consent to share via the platform, they do share results via email or face-to-face, we recognise this isn't happening in all sites. You may find it helpful to remind social workers that once they have viewed their results online, they can amend their decision to share the result with you, should they wish to do so. They need just tick the consent box.

• **Next steps:** In our newsletter later this month, we will have more information to share about NAAS beyond the end of Phase 2 (March 2020).

## **Knowledge Hub: NAAS digital network**

We are trialling a new way for NAAS sites to connect, gather insight and share learning. Knowledge Hub is a tool used for digital networking across the public sector. After a quick sign-up process, it allows members to host discussions, upload documents and much more, in a free, secure environment. 
